- Remove Retaining Clip, Protector, and Spring.Install Spring Spacer and reinstall components.








- Remove Shock and repeat steps for opposite Front Shock.
 Reinstall Front Shocks to machine with stock hardware.









Rear Spacer


- Remove Protector and disconnect Shock from A-Arm.
